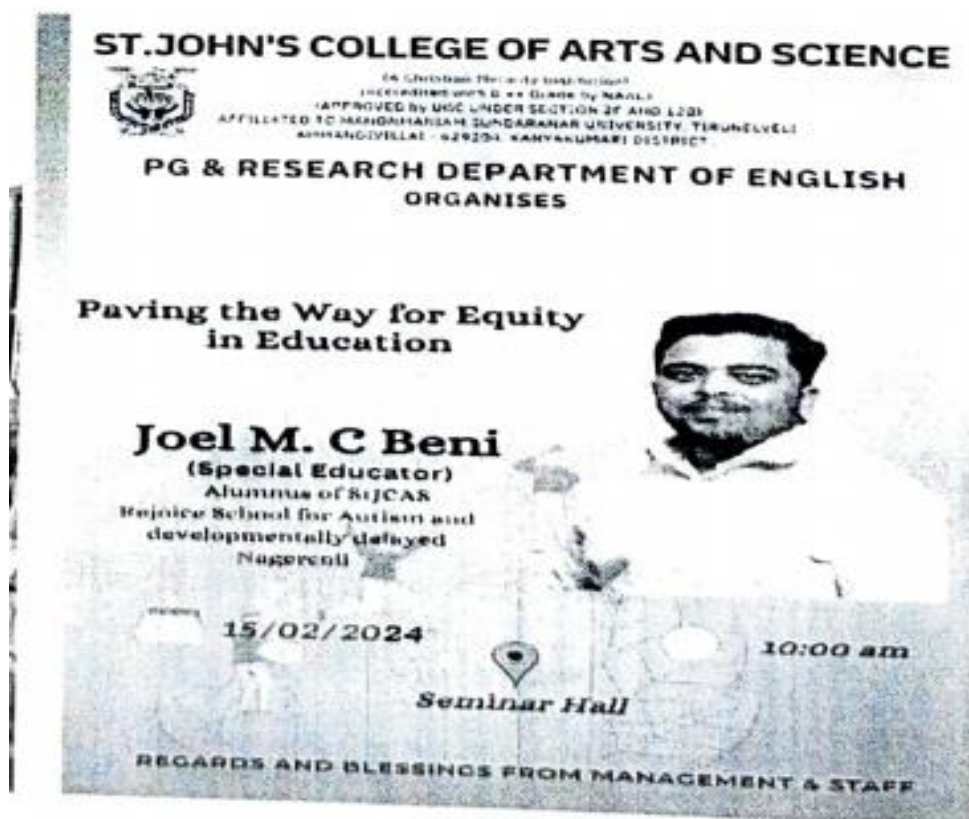

Selected papers will be published in a book with ISBN No. After double-blind peer review, suggested articles will be published in UGC care list Journals.
