This Memorandum of Understanding (MoU) is entered into on 05/04/2024 between **ST. JOHN'S COLLEGE OF ARTS & SCIENCE**, located at St. John's College Road, Ammandivilai, Kanyakumari District – 629 204, Tamilnadu, India, and **VIRUDHUNAGAR HINDU NADARS' SENTHIKUMARA NADAR COLLEGE**, located at 3/151-1 College Road, Virudhunagar – 626001, Tamilnadu, India.

#### **Preamble**

Recognizing the mutual interest in fostering educational collaboration and cooperation for the benefit of their students, **St. John's college of Arts & Science**, Ammandivilai, Kanyakumari District – 629 204 and **Virudhunagar Hindu Nadars' Senthikumara Nadar College**, Virudhunagar – 626001 intend to establish a framework for joint initiatives in the field of English language education. This MoU outlines the terms and conditions under which both institutions will collaborate to organize conferences, workshops, seminars, student exchanges, virtual programs, projects, and other activities for the enhancement of academic and cultural experiences.

#### **Article 1: Objectives**

1.1 The primary objectives of this MoU are to:

- a) Foster academic and cultural collaboration between the English Departments of **St. John's college of Arts & Science**, Ammandivilai, Kanyakumari District – 629 204 and **Virudhunagar Hindu Nadars' Senthikumara Nadar College**, Virudhunagar – 626001.
- b) Create opportunities for joint educational activities that enrich the learning experiences of students from both institutions.
- c) Promote the exchange of knowledge, expertise, and best practices in English language education.

#### **Article 2: Collaborative Activities**

2. 1. Both institutions agree to collaborate on the following activities, but not limited to:
  - a) Joint conferences, seminars, and workshops on topics related to English language, literature, linguistics, and related disciplines.
  - b) Student exchange programs to provide students with cross-cultural experiences and exposure to diverse educational environments.
  - c) Virtual programs, including online courses, webinars, and virtual lectures, to expand access to educational resources.
  - d) Collaborative research projects, publications, and academic materials development.



- e) Sharing of teaching methodologies, curriculum design, and assessment practices.

**Article 3: Implementation**

3. 1. Both institutions shall establish a Joint Committee, consisting of representatives from the English Departments of **St. John's college of Arts & Science, Ammandivilai, Kanyakumari District – 629 204** and **Virudhunagar Hindu Nadars' Senthikumara Nadar College, Virudhunagar – 626001**, to oversee the planning, coordination, and implementation of collaborative activities outlined in this MoU.

**Article 4: Financial Arrangements**

4. 1. The financial responsibilities for each collaborative activity shall be determined and agreed upon by both institutions on a case-by-case basis. Both institutions commit to seeking external funding and sponsorships to support joint initiatives whenever possible.

**Article 5: Duration**

5. 1. This MoU shall become effective on the date of signing by both parties and shall remain in force for a period of three years from the effective date. It may be renewed by mutual written agreement of both parties.

**Article 6: Termination**

6. 1. Either party may terminate this MoU by providing written notice to the other party at least one month prior to the intended termination date.

**Article 7: Amendment**

7. 1. Any amendment or modification to this MoU shall be made in writing and shall require the mutual consent of both parties.

**Article 8: Governing Law**

8. 1. This MoU shall be governed by and construed in accordance with the laws of Tamil Nadu

**Article 9: Entire Agreement**

9. 1. This MoU constitutes the entire agreement between **College St. John's college of Arts & Science, Ammandivilai, Kanyakumari District – 629 204** and **Virudhunagar Hindu Nadars' Senthikumara Nadar College, Virudhunagar – 626001** with respect to the subject matter hereof and supersedes all prior discussions, understandings, and agreements.



**MEMORANDUM OF UNDERSTANDING**

### **PURPOSE**

### **TYPES OF COOPERATION**

Through this memorandum, **PARTIES** affirm the value of mutual collaboration and agree to promote the following activities:

1. Joint research projects in the fields of mutual interests;
2. Exchange of academic publications and reports;
3. Opportunities for faculty and staff development and exchange;
4. Exchange of visiting research scholars, including advanced graduate students;
5. Other activities as mutually agreed.

This Agreement places no financial obligations or supplementary funding commitments on either **PARTY**. These activities will be defined through separate program agreements that detail the commitment of resources (financial or otherwise) required by each Institution. Subsequent program agreements must be approved in writing by the authorized representatives of each institution.




## TERMS

This agreement will become effective upon the date of signature by both **PARTIES**. It shall remain valid for five (5) years from the date of the last signature, with the understanding that it may be modified by written mutual consent of both **PARTIES**. This Agreement may be terminated by either **PARTY** with the advance written notice of at least thirty (30) days. Upon notice of termination, both **FIRST PARTY** and **SECOND PARTY** agree to work in good faith to enable visiting scholars to complete their respective research programs unhindered by the termination. The agreement may be extended by mutual consent of the two **PARTIES** after the five years, and it must be renewed in writing. This Memorandum of Understanding in English is hereby signed in two (2) copies with one (1) copy remaining in the possession of each **PARTY**.
